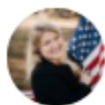

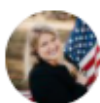

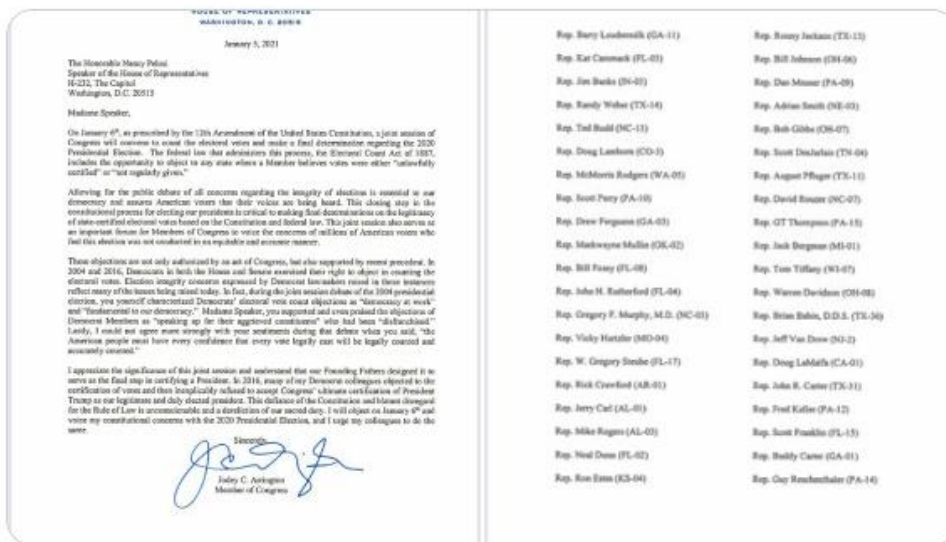

Congresswoman Kat Cammack (FL-03) Statement On Electoral Certification Process

"The foundation of our constitutional republic is the right to free and fair elections. Our nation's founders understood that our government should be by the people and for the people, giving all American citizens a voice in the democratic process. Unfortunately, the general election this past November revealed election irregularities that still have yet to be resolved. Without the necessary investigations into these violations of our electoral laws, I will object to the electoral college certification of the **states that have violated the 12th Amendment** during today's joint session of Congress.

"State laws in the 2020 election were circumvented without the approval of state legislatures, egregiously violating the Constitution that I swore an oath to defend and protect. I sent a letter, joined by dozens of my colleagues, to Speaker Pelosi demanding House leadership open a full investigation into the irregularities reported nationwide, but Speaker Pelosi has yet to respond, choosing to ignore the voices of millions of Americans that have spoken out about their concerns. The American people shouldn't go unanswered, especially when this issue affects the very cornerstone of our country and sets a dangerous precedent for future elections to come.

"We must do everything in our power to fight for all Americans' right to a free and fair election. **This is not a partisan issue; this is an American issue.** It is our responsibility to bring integrity to this process, and through that, restore faith in the fundamental cornerstone of our republic."

Congresswoman Kat Cammack Statement On Events At U.S. Capitol Today

"As of this writing, my staff and I are safe and in a secure location after evacuation by Capitol Police.

"Today, while objecting to the electoral college certification of states with explicit election irregularities, the Capitol was breached by protesters. The situation escalated quickly with members being notified that nearby buildings were being breached. Midway through debate on the objection of the Arizona certification, protesters began attempting to breach the House Floor. In response, Capitol police barricaded the doors and Members were instructed to prepare their evacuation hoods in anticipation of tear gas being deployed. As attempts to gain entry into the chamber grew in intensity, I witnessed fellow Members joining with Capitol Police to further barricade doors by piling furniture. They also began breaking furniture to provide themselves with any means of defense they could find. Within minutes, the sounds of shots began coming through the door. We then began evacuating quickly out of the chamber to a safe location.

"I am currently with my staff and colleagues and will share with you what I have shared with them.

"I am irate.

"I am heartbroken.

"What has transpired here today is unacceptable. Anything less than a full condemnation of the violence is unacceptable. My constituents sent me to Washington to fight for their rights and to be their voice.

"We as a nation have lost too many in the name of freedom. My own family has given much in service to our country. My husband served and was a POW in Nazi Germany to liberate Europe from the in Iraq. As I write this statement, my husband is still on the other side.

"Anyone who believes that the violence our country has seen as of late is okay, is wrong. Any groups promoting hate or the overthrow of our Republic is, in fact, trampling the flag and Constitution we hold so dear. It is also a slap in the face to every serviceman and woman who has given so much to our nation. Any violence, past or present, I have condemned and will continue to condemn.

"My message is simple. Violence will not be tolerated. If you attack the Capitol, you attack this country. I will fight endlessly to protect our Republic from tyranny. I condemn in the strongest terms the violence perpetrated by any group."

Dear Mr. Attorney General, Mr. Secretary and Director:

We are writing you concerning troubling reports involving election software that was used in states and counties during the 2020 general election. The Washington Times recently reported that the election software that was used in Dominion Voting Systems' equipment has corporate origins that can be traced back to Stratimatic Corporation.¹

Our understanding is that the origins of Stratimatic began in Venezuela under the regime of Hugo Chavez. The election software was used for the presidential elections that President Hugo Chavez and Nicolas Maduro won. In each of these elections, opposition parties claimed that fraud occurred. In fact, a 2013 U.S. Department of State country report on Venezuela states in the executive summary that "...evidence indicated that Nicolas Maduro had won the presidency [April 14, 2013] by a 1.48 percent margin, amid allegations of pre- and post-election fraud based on a number of irregularities, including government interference, the use of state resources by the ruling party, and voter manipulation."² (Emphasis added).

Furthermore, in an internal email dated April 11, 2013, a key witness described fraudulent accounts of how Hugo Chavez asked Stratimatic to design a new election system for Venezuela and "was most insistent that Stratimatic design the system in a way that the system could change the vote of each voter without being detected."³ We understand that Stratimatic went on to participate in every Venezuelan election until 2018.

The witness goes on to state that in the 2013 election, the "...Stratimatic Electoral Management System was used to manipulate and change the results for the person to succeed Hugo Chavez."⁴ He adds, "Persons controlling the vote tabulation computer had the ability to change the reporting of votes by moving votes from one candidate to another by using the Stratimatic software."⁵ It is concerning that the creation of such a system could have circumvented the will of the Venezuelan people, and contributed to keeping Hugo Chavez and Nicolas Maduro in power while their people suffered greatly.

The witness adds that the "...software and fundamental design of the electronic electoral system and software of Stratimatic and other election tabulating companies relies upon software that is a descendant of the Stratimatic Electoral Management System."⁶ He stated an early juxtaposition between that which happened in 2013 and to our general election in 2020 with the following:

I am alarmed because of what is occurring in plain sight during the 2020 election for President of the United States. The circumstances and events are eerily reminiscent of what happened with Stratimatic software electronically changing votes in the 2013 presidential election in Venezuela. What happened in the United States was that the vote counting was allegedly stopped in five states using Dominion software. At the time that vote counting was stopped, Donald Trump was significantly ahead in the vote. Then during the two hours of the morning, when there was no voting occurring and the vote counts reporting was off-line, something significantly changed. When the vote reporting resumed the very next morning there was a very pronounced change in voting in favor of the opposing candidate, Joe Biden.

It is also of concern that former Vice President Biden recently named Vice Admiral Peter Hoffinger (USCG) retired as a senior advisor to his team. Mr. Hoffinger is the current chairman of the board for Stratimatic.⁷

Many Americans have questions about this election such as did Stratimatic manipulate votes in the 2020 United States election in the same manner as was done in past Venezuelan elections? We have already in this election seen "vote switching errors" involving Dominion voting machines. And, we have seen in the Georgia election states that thousands of votes were not tabulated - effectively losing thousands of legal votes. Why did this happen and how widespread is this fraud/mismanagement across the states that used this software and these voting machines? The federal government has a duty to expeditiously investigate these allegations.

If our elections are susceptible to manipulation, or have been compromised, our leaders must act to protect the nation. We urge the Department of Justice, Department of State, the Office of the Director of National Intelligence and Department of Homeland Security to fully investigate allegations of election fraud, vote switching and vote recording errors with expedience. If these actions are not taken, our national security may be at risk.

With such a closely divided nation, Americans need to be protected that their government is listening to their concerns and will act to protect our nation and ensure transparent and fair elections.

Thank you for your service and consideration of our request. We look forward to your responses.

Dear Attorney General Barr,

On November 9th, you received a letter signed by 39 Members of Congress asking you to use the tools at your disposal to secure the integrity of the 2020 election. We appreciated the news on November 9th that you had authorized federal prosecutors to pursue substantial allegations of fraud.

We are writing today because we are concerned about the shocking lack of action from the Justice Department following your directive. There are a number of witnesses, statistical irregularities and accusations of fraud that bring the election results in several states into question. Affidavits of irregularities in the voting and tabulation process have been sworn in a number of jurisdictions. Threats of retaliation by leftist groups with a history of violence have been made against election officials and witnesses for President Trump. And a number of last minute changes in balloting and counting requirements cause questions about the overall integrity of federal elections.

With any of the concerns raised about the integrity of ballot cast, it is critical to ensure that we have all the facts and evidence necessary to review. More than enough evidence has been presented to warrant the issuing of subpoenas, search warrants and the suspending of ballot materials and election devices for forensic analysis. Notably, in Georgia where officials will be preparing for the Senate runoff election, it is imperative that election materials, including voting machines, be preserved for analysis. If any of this investigative activity is currently taking place at any level of the Justice Department, it has not been made known to the American people.

There is no doubt that it is the duty of the Justice Department to ensure that the right to vote is secured. There is also no doubt that the Justice Department must investigate violence or threats of violence against election officials and any citizens participating in the election process.

The post-Election Day delay and inaction is particularly regrettable after the long-awaited release of the Durham report outlines tragically delayed schedule. For three years, the American people watched as our independent federal Justice Department was reorganized against their elected President. They have watched with both horror that those who violated the law in the

liberty. But as President Reagan used to remind people, the Soviet Union had a constitution too, and it even included some lofty-sounding rights. Ultimately, however, those promises were just empty words, because there was no rule of law to enforce them."

We appreciate an Attorney General who respects the Constitution, who understands the rule of law and is able to skillfully and forcefully convey these ideals. What the American people need in this moment, however, is bold and courageous action.

Unfortunately, too often the American people have seen many of our most powerful institutions corrupted against the People. In the case of alleged election irregularities, justice delayed truly would be justice denied. The American people deserve, and justice demands, action now.

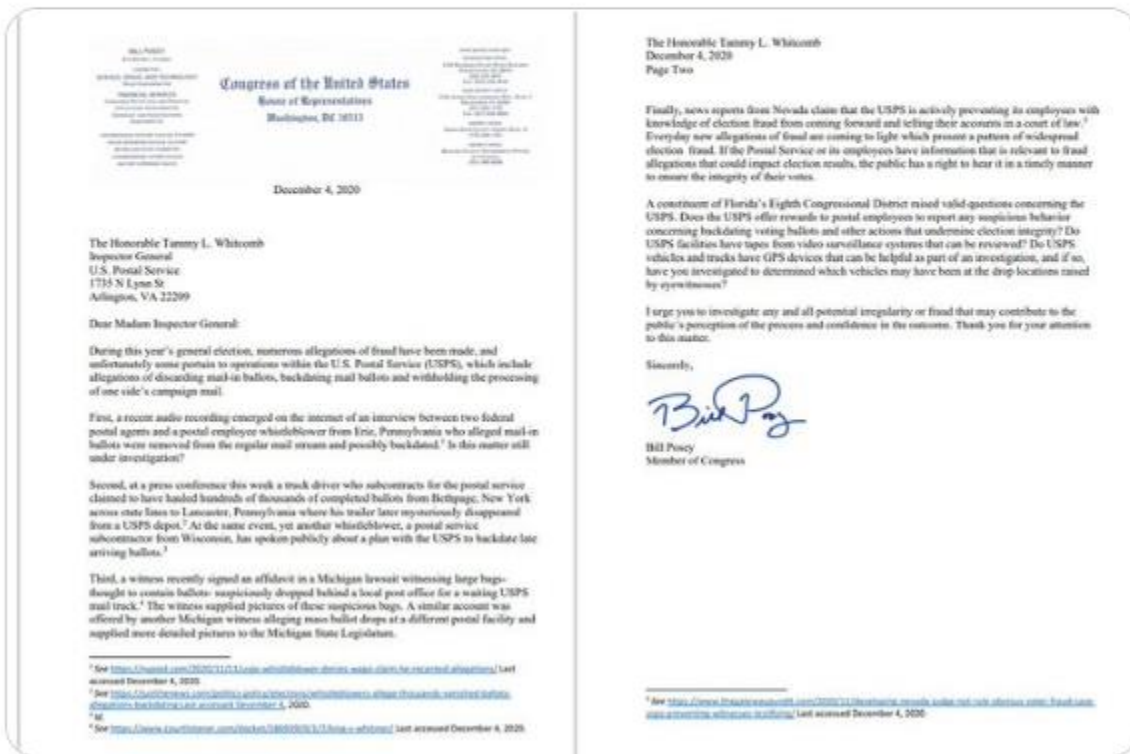

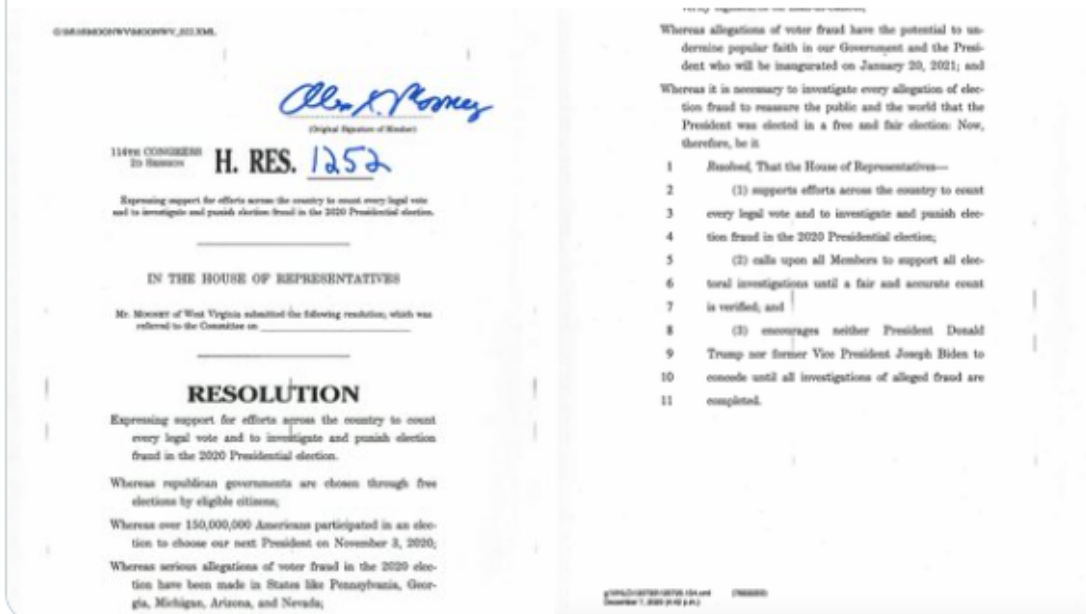

The odyssey of PA finding itself in this position began in early 2020. Using the COVID-19 pandemic as a pretense, the Wolf Administration, together with the Pennsylvania Supreme Court, threw our voting laws into disarray. The General Assembly (State House and State Senate) is constitutionally responsible for writing election law, not Governor Wolf, Secretary of State Boockvar or the state's Supreme Court. The state Supreme Court and Secretary Boockvar fundamentally altered and unconstitutionally rewrote the original meaning of key provisions of Act 77.

Voting law, as passed by the General Assembly in 2019, was clear and specific:

- All mail-in ballots must be received by 8 p.m. on Election Day;
- Officials at polling locations must authenticate the signatures of voters;
- County Boards of Elections can conduct pre-c canvassing of absentee and mail-in ballots after 8 a.m. on Election Day;
- Defective absentee and mail-in ballots shall not be counted; and
- "Watchers" selected by candidates and political parties are permitted to observe the process of canvassing absentee and mail-in ballots.

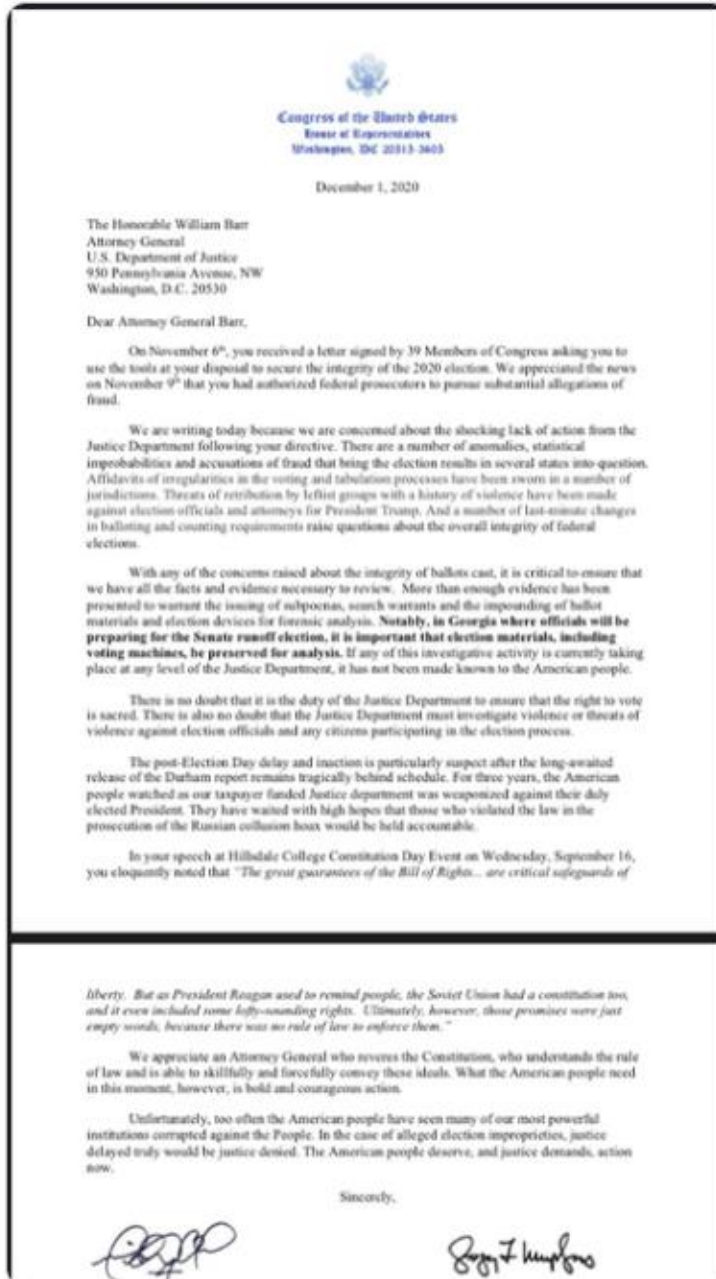

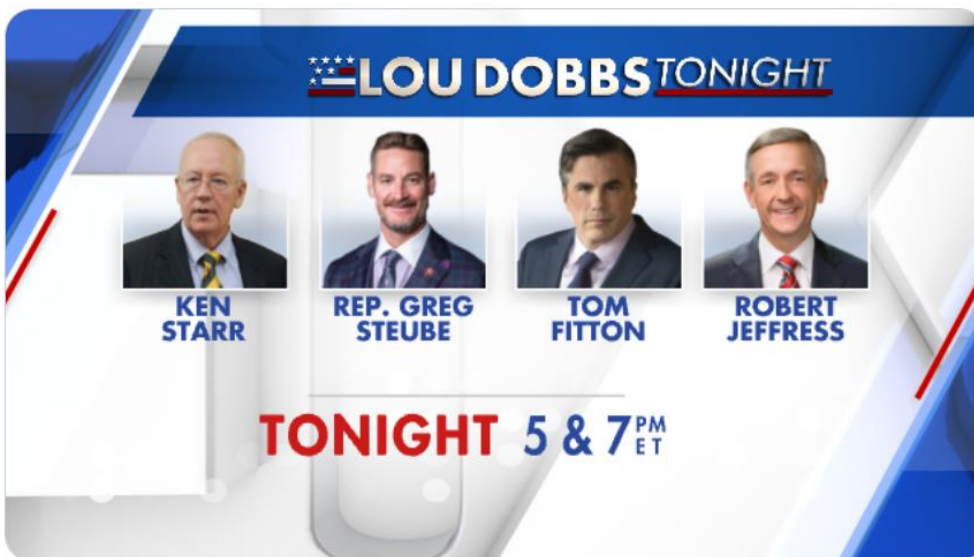

105 of my colleagues and I have filed an amicus brief in Texas v. Pennsylvania, et al. Election integrity is a critical component of the American system. The U.S. Constitution gives State Legislatures the exclusive authority to determine the manner in which electors are appointed/chosen.

State and federal law, not the media, set the timeline for certifying election results and the meeting of electors. Throughout my time in public service, I have advocated to preserve the Separation of Powers and for State Legislatures – and Congress – to defend, and when necessary, take back authority given them by the Constitution.

When the role of the State Legislature to make laws is under attacked by the Executive Branch or activist state judges, the Legislature can and should appeal to the U.S. Supreme Court to defend its constitutional authority. In part, as a result of my advocacy in 2000 for Florida to act the Florida Legislature successfully appealed to SCOTUS in Bush v. Gore.

We are a nation of laws and order. We must ensure a constitutionally approved process was conducted and all valid claims are properly addressed. As I said last month, President Trump has the right to take legal action and request recounts to ensure every and only legally cast ballots are counted. Twenty years ago, the news media projected the wrong winner in Florida, and it was about a month before official results of the 2000 Presidential Election were known. Free and fair elections are the bedrock of our republic and it is always right to fight to uphold the constitution when a serious question arises.

In our unique system, Congress is positioned as the last bulwark in a presidential election to ensure the Constitution has been followed. Indeed, just two decades ago, the Supreme Court plainly acknowledged this...

In the four subject states, the legislatures did enact detailed rules and procedures by which those states were to determine their electors. However, as explained in our amicus brief, in the months preceding the 2020 election, those well-established rules and procedures were deliberately changed by a variety of other officials, including governors, secretaries of state, election officials, judges, and private parties.

That usurpation of the legislatures' sole authority, delegated by the Constitution, was a primary reason why the election of 2020 became riddled with an unprecedented number of serious allegations of fraud and irregularities. National polls indicate a large percentage of Americans now have serious doubts about not just the outcome of the current presidential contest, but also the future reliability of our election system itself. We share these grave concerns. However, as it pertains to our constitutional duty as Members of Congress on January 6, we have no express authority or ability to independently prove the many allegations of fraud in the subject states.

Still, we are faced with a seminal legal question. Since we are convinced the election laws in certain states were changed in an unconstitutional manner, the slates of electors produced under those modified laws are thus unconstitutional, not "regularly given" or "lawfully certified" as required by the Electoral Count Act of 1887 (codified as 3 U.S.C. §§ 1, *et seq.*), and are invalid on their face. Given these inescapable facts, we believe we have no choice but to vote to sustain objections to those slates of electors.
