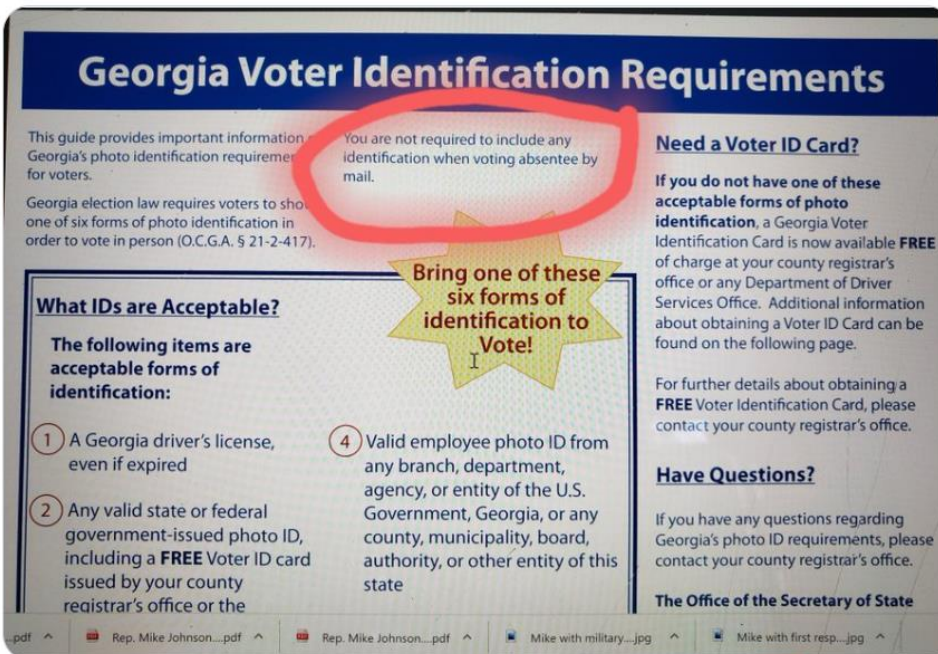
Why a GA recount?

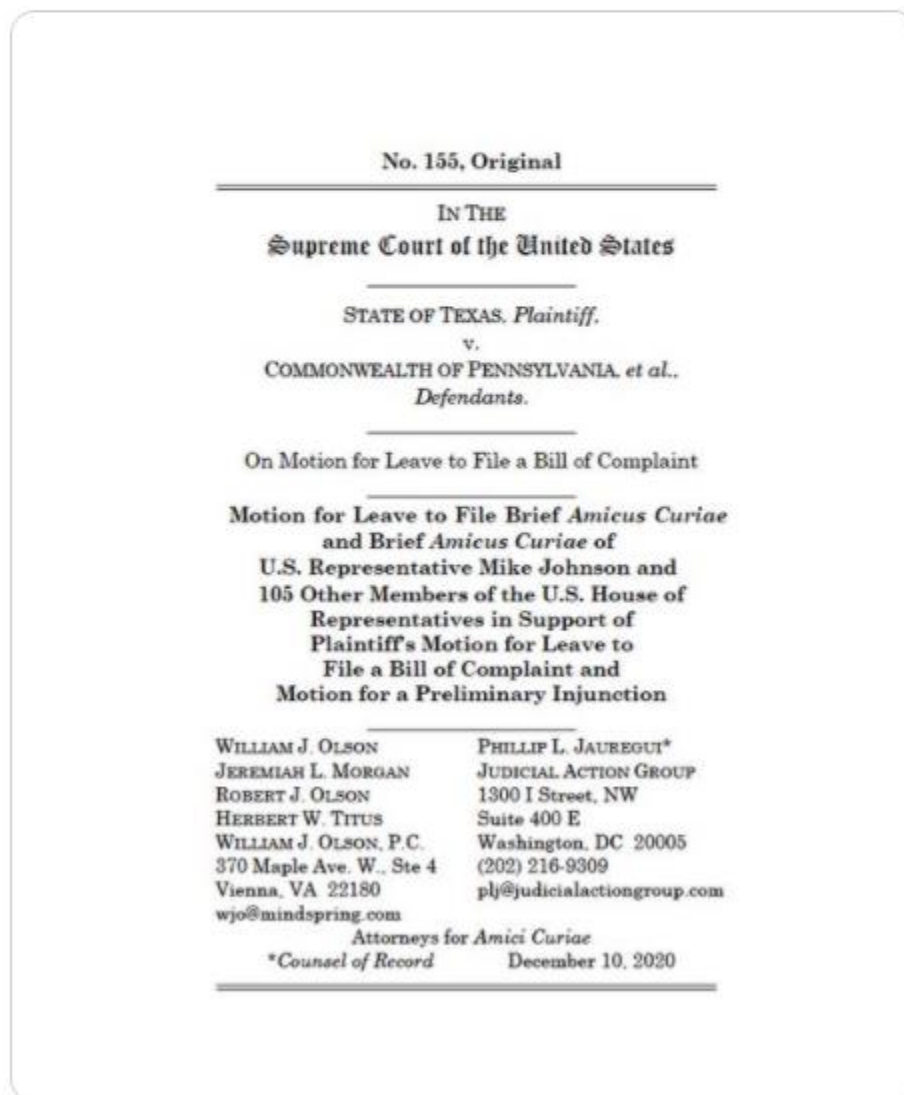
