Congressman Louie Gohmert (TX-01) released the following statement regarding the lawsuit filed against the Vice President:

"The 2020 presidential election was one we'd expect to see in a banana republic, not the United States of America. In fact, the rampant fraud and unconstitutional actions that took place were so egregious that seven contested states-- Arizona, Georgia, Michigan, New Mexico, Nevada, Pennsylvania, and Wisconsin all sent dueling slates of electors to Congress. This puts Vice President Mike Pence in a position where some argue he has to choose between morality and the law. That is not the case.

"It is also critical to note that as many formerly in the mainstream media, now the Alt-Left media, continue to say that every court has said there is no evidence of fraud. That is disingenuous, deceitful, and flat out dishonest. The truth is that no court so far has had the morality and courage to allow evidence of fraud to be introduced in front of it.

"We continue to hold out hope that there is a federal judge who understands that the fraud that stole this election will mean the end of our republic, and this suit would insure that the Vice-President will only accept electors legitimately and legally elected. There must be an opportunity for a day in court when fraud was this prevalent.

"It is for this reason that I and other plaintiffs have filed a complaint for expedited declaratory and emergency injunctive relief to seek judgment from the court on the Vice President's authority when presiding over the Senate during the Joint Session of Congress. We are asking the court to uphold the powers laid out in the United States Constitution which grant the Vice President the exclusive authority and sole discretion in determining which electoral votes to count. As outlined in the filing, the Electoral Count Act is unconstitutional because it directs Vice President Pence to legitimize electoral votes in violation of the Electors Clause and limits or eliminates his Twelfth Amendment authority to determine which slates of electors should be counted and which, if any, may not be counted. This is fundamental because no statute can constitutionally supply rules to the extent that such statute violates the U.S. Constitution.

Thanks to spineless politicians, corrupt state officials and a coordinated effort to undermine the will of the American people in favor of business as usual in the D.C. swamp, we now find ourselves in a place where a stolen election becomes just another one of the miscarriages of justice this town refuses to remedy. Yet, the voices of tens of millions of Americans must be heard, respected, and acted upon in order to ensure the integrity of our elections is strengthened and never again allows actions that undermine our nation and sow such tremendous distrust in our electoral process. American elections must be conducted freely, fairly, and Constitutionally.

Early this morning, I voted to object to the elections from the state of Pennsylvania because it was clear to me this state's election was conducted unconstitutionally through executive and court actions which changed the rules of the election without the express approval of the Pennsylvania State Legislature.

The actions to change election rules in Pennsylvania were so egregious, that on October 26, 2020, Justice Samuel Alito, joined by two other Supreme Court Justices, wrote:

*"It would be highly desirable to issue a ruling on the constitutionality of the State Supreme Court's decision before the election. That question has national importance, and there is a strong likelihood that the State Supreme Court decision violates the Federal Constitution. The provisions of the Federal Constitution conferring on state legislatures, and state courts, the authority to make such decisions reflect a strong*

Republican and Democratic parties – ruled on because it is of utmost importance to the American people and of elections to be held in the future. If State Supreme Courts and executive offices are allowed unrestricted ability to change election laws at any time, and without the approval of state legislative bodies, then we have truly surrendered a fundamental bedrock of our Republic.

Although democrats have routinely objected to the acceptance of elections in past elections, I understand that by objecting to the 2020 Pennsylvania elections I will be unjustly stoned as a traitor and secessionist. But I stand with tens of millions of Americans who can forcefully and righteously agree with Supreme Court Justices who understood the actions to change election rules in Pennsylvania represent a grave Constitutional threat that must be remedied.

While I did not support the objection of elections from the state of Arizona, I believe voting against elections from Pennsylvania was constitutionally correct and our best opportunity to stand up for federalism, the rule of law, and justice that is owed to the American public. I am grateful for others who rose with me in support of this most reasonable of requests to protect the sanctity of our Republic, the just conduct of our elections, and a fair review that is owed to all Americans.

Like many of you, I worked tirelessly on behalf of, and prayed fervently for, a different outcome. While that did not occur, we must commit to forge forward together, agreeing where it makes sense and promoting the general welfare of all Americans, while vigorously but peacefully disagreeing where ideology and visions diverge. Regardless, we move forward together in this dream, this experiment, this wonderful nation that we are all blessed to call our home, that we are all blessed to call our United States of America."
